# What are Accounting Technicians?

Accounting Technicians are qualified accounting professionals that work at all levels of finance. They can work in all types of organisations and are widely employed throughout the public sector, industry and commerce and in private accountancy practices.

They are involved in the day-to-day practical work of accountancy and play a key operational role in producing reliable financial information. Accounting Technicians can perform a wide range of finance roles, from accounts staff to financial controller and beyond. For instance, they can do financial accounting and budgeting, costing and credit control, payroll administration and tax returns. More experienced Accounting Technicians may often perform senior managerial tasks and audits.

Accounting Technicians can work on their own or alongside professional accountants. In a small company, they may be the only qualified employee looking after the finance function, while in a larger company, they may be working as part of a team alongside accountants and administrative staff. While they are not accountants, they can perform many of the same functions and are qualified to take accounts beyond trial balance stage, as well as prepare full financial accounts.

# What is Accounting Technicians Ireland?

#### Accounting Technicians Ireland is the leading Accounting Technician body with over 10,000 members and students across the Republic of Ireland and Northern Ireland.

Established in 1983, Accounting Technicians Ireland prides itself on providing an internationally recognised accounting qualification and on promoting the highest educational, technical and ethical standards to its members.

Its qualification combines professional exams with practical work experience. As qualified members of Accounting Technicians Ireland, individuals are entitled to use the designation MIATI after their name, seen by many employers as essential when hiring.

Accounting Technicians Ireland is a partner body with Chartered Accountants Ireland and an associate member of the International Federation of Accountants. It has offices in Dublin and Belfast and links with local college networks throughout Ireland.

# Why would I be interested?

Accounting Technicians enjoy excellent career prospects and there is always a strong demand for their skills in the marketplace. Indeed, results from our most recent member survey show that almost 95% of our members are employed.

They can work in a wide variety of finance roles for many types of organisations, including manufacturing companies, local and central government, the health service, banks and insurance companies and private accountancy firms. Self-employment is also a possibility for qualified technicians.

In addition, many who qualify as Accounting Technicians go on to continue their studies, using the qualification as a stepping stone to eventually becoming professional accountants with one of the other accounting bodies.





# What is the jobs market like for accounting?

Careers in accounting and finance can be very rewarding and those with lots of experience often receive very high salaries. Indeed, studies show that many accounting graduates often end up in senior management positions.

There is a great variety of work within the accounting profession with a bewildering array of career opportunities to suit all interests including auditing and assurance work, consulting, corporate finance, tax planning, and insolvency.

Despite the challenging economy, the overall jobs market for accounting and finance in Ireland remains positive. Indeed, the National Skills Bulletin 2011 which is produced by the Expert Group on Future Skills Needs has identified accounting and finance as a sector where there are skills shortages.

There are over 100,000 persons employed in a range of accounting and finance professions (making up almost 6% of Ireland's workforce) and the report highlights skills shortages in the areas of risk analysis, management and cost accounting, compliance and regulatory standards, and global and financial analysis.

There are also opportunities in finance support roles in several niche areas, including credit control, debt recovery, anti-money laundering, and some specialist roles in supply chain operations.

# How do I become an Accounting Technician?

# Who studies to be an Accounting Technician?

Our students come from all walks of life. For example, you may already be working or going to college, or perhaps you are a mature student who wants to get back into the workforce. You could even be currently working in an accounting related area, and although experienced, wish to pursue a formal qualification.

### Can you tell me about the Accounting Technicians Ireland qualification?

Our Diploma for Accounting Technicians consists of two elements, which can be completed simultaneously or at different stages:

- Two year programme of study
- Two year work based learning

Depending on your circumstances, the qualification can be studied full-time, part-time or on a correspondence basis, allowing students to study at a pace that fits their lives.

#### Full-time

Full-time courses are available in a wide number of colleges aimed at students who want to devote themselves full-time to preparing for the Accounting Technicians Ireland exams. Typically speaking, these courses are usually run over four weekdays.

Full-time courses are also provided to the unemployed in a number of FÁS training centres in the Republic of Ireland.

#### Part-time

If you want to study part-time, there are many courses available. These normally involve evening lectures twice a week, although some colleges will deliver day-time options for part-time students.

#### Correspondence

If it's not convenient to attend a lecture-based course, you can enrol as a correspondence student. This way you can study from home using tutorial materials.

Obviously, these course options have different time commitments and thus will impact your availability for gaining work experience – assuming you do not already have the required two years experience.

For instance, students choosing to study part-time or on a correspondence basis can opt to work during the day while they are studying at night, and gain valuable experience towards their qualification. For those studying full-time, it will take a little longer to gain the required work experience and qualify.

### What are the entry requirements?

We offer a number of different entry routes to students depending on your circumstances.



**Mature learners** who have reached 21 years of age (by the 1st January of the year in which they wish to commence the course) but do not possess the minimum educational requirements, may still apply to do the course based on age and experience.

**School leavers** in the Republic of Ireland should have a Leaving Certificate with pass grades in 5 Ordinary level subjects (including English and either Maths or Accountancy), or pass grades in 2 Ordinary level subjects together with 2 pass grades at Higher level (pass grades to include English and either Maths or Accountancy). Applied Leaving Certificate applicants should contact the Registrar on Tel: 01-6498120 for further information.

School leavers in Northern Ireland should have 1 A Level or 2 AS Levels with grades in English and at least one subject from Maths or Accountancy not lower than grade C at GCSE level.

Applicants who have successfully completed a nationally recognised qualification such as HETAC, FETAC in the Republic of Ireland or QCA, BTEC National Diploma in Northern Ireland may be eligible to enter and gain exemptions from certain exam subjects. Further information is available upon request.

## Can I get exemptions?

You may apply for exemptions from some or all First Year subjects if you have previously completed other qualifications such as HETAC, BTEC or equivalent course of study. Irish honours degree holders of a relevant subject area may be entitled to a full First Year exemption. The closing date to apply for exemptions is 1st October 2012 and application forms, along with further information on Accounting Technicians Ireland's exemption policy, are available on www.AccountingTechniciansIreland.ie/exemptions

Please note that exemptions are not offered for Second Year subjects.



# Where can I study?

Accounting Technicians Ireland courses, both full-time and part-time, are available at over 70 colleges throughout the Republic of Ireland and Northern Ireland. These currently include VECs and Institutes of Technology, and leading private and community colleges.

In 2012, Accounting Technicians Ireland is delighted to partner with a number of new colleges in Dublin. These include IBAT College in Temple Bar and the Institute of Finance Training in Sandyford.

#### Accounting Technicians Professional Education Training Centre

Accounting Technicians Professional Education Training Centre is also registering both First Year and Second Year students. Lectures take place two evenings a week at Accounting Technicians Ireland's head office, 47-49 Pearse Street, Dublin 2. For further details, please call 01-6498120 to request a brochure.

A Correspondence Learning programme is also available to allow students study from home using tutorial materials.

#### **FÁS Centres**

Our programme is delivered in the Republic of Ireland through FÁS in a number of their training centres. First Year and often Second Year courses are available and the programme is run on a full-time basis across a 38 week period.

The majority of FÁS training courses are free to the unemployed so please contact your local Employment Services Office to register and discuss the training options available.



# What is the Diploma for Accounting Technicians?

The course allows you to work as an Accounting Technician professional in the corporate or public sector, or in private practice. It also offers you the opportunity to pursue further professional accountancy qualifications with one of the other professional accountancy bodies.

Our Diploma syllabus has been carefully designed to combine the theory and practical aspects of technical knowledge of finance and accountancy practice. It also explores the concepts of business culture and business ethics and introduces the key management functions across the whole spectrum of business activity. The result is that our graduates are equipped with an array of transferable business skills, as well as technical knowledge of finance and accountancy practice.

First Year provides a foundation knowledge of business, accounting and tax, while Second Year provides a deeper understanding of the more advanced accounting issues. There is also a practical focus in Second Year on accounting and payroll software systems that are commonly used in the workplace by finance departments.

You are also required to gain experiential learning through two years full-time employment (or the equivalent part-time). This could include relevant work experience from a previous job or voluntary activity for a group or society.

#### Accreditation

The Diploma for Accounting Technicians is fully approved as a Level 5 on the Qualifications and Credit Framework (QCF) in England, Wales and Northern Ireland. This equates to a Level 6/7 on the National Framework of Qualifications in the Republic of Ireland. Successful graduates will receive the award of Diploma for Accounting Technicians Level 5.

#### **Further Studies**

The course is structured to maximise exemptions with leading professional accountancy bodies such as our partner Chartered Accountants Ireland; the Association of Chartered Certified Accountants (ACCA); the Institute of Certified Public Accountants (CPA); the Chartered Institute of Management Accounting (CIMA); and the Institute of Incorporated Public Accountants (IIPA).

# Will I have to sit exams?

Yes and you have a maximum of ten years\* to successfully complete all exams which means that you can take them at your own pace. However, most students will complete the exams over a two year period. Students will be credited with a pass in individual papers if they obtain 50% or higher. There are 16 exam centres nationally for students to choose from.

\* All First Year exams must be successfully completed within six years of registration.

# What are the fees?

Students pay both professional fees to Accounting Technicians Ireland and tuition fees to the college where they are studying. Professional fees will cover your student registration, textbooks, exams, and other student supports that you receive.

The tuition fees you pay to your college will vary depending on whether your course is full-time or part-time, or in a public sector college or private institution. College fees can vary significantly so students are advised to shop around.

Please note that you must register with Accounting Technicians Ireland and also with the college where you intend to study. You can register with Accounting Technicians Ireland from 2nd July 2012 until the closing deadline of 26th October 2012.

# Pricing examples

#### **Stepped Payments**

This year Accounting Technicians Ireland is continuing its stepped payment facility to allow students to spread the cost of their payments over four installments during the course of the academic year. This facility is only available to new students who register online before 26th October 2012 at www.AccountingTechniciansIreland.ie/register

Students who register online before 26th October 2012 can spread the cost of their payments for Student Registration, Textbooks and Examinations over four payments, with the first payment\* charged at **registration stage**, and then the remaining payments being charged on **30th November 2012, 25th January 2013, and 22nd February 2013.** To avail of this facility, you must register with Accounting Technicians Ireland online. All payments will be charged to either your debit/credit card on the above dates.

\* An administration fee of 3% of the total amount purchased will be charged on your first payment.

#### **Pricing Example**

Linda is an incoming First Year student. She is studying all four First Year subjects and will be sitting exams in May 2013 for all subjects. The total cost to Linda for all of the above is €650 and is made up of the following elements:

- Student registration of €150
- Textbooks fee of €220 (for four subjects)
- Examination fee of €280 (for four subjects)

Total Cost is €650

Linda can register online at

www.AccountingTechniciansIreland.ie/register and avail of one of the following payment options:

- 1. Pay a total of €650 for her registration, textbooks and exams at the time of registration.
- Avail of the stepped payment option and spread the total cost of €669.50 (€650 plus 3% administration fee) over four payments throughout the academic year on the above dates. (So in Linda's example, she will pay €182 at Registration stage, and then pay €162.50 for each of the second, third, and fourth payments.)
- 3. Alternatively use stepped payments to spread the cost of her registration and textbooks €381.10 (€370 plus 3% administration fee) over four payments throughout the academic year and pay for her examinations separately before the closing date on 25th January 2013.

If Linda does not have access to the online registration facility she can submit the Student Registration Form at the back of this prospectus.

All credit card transactions (with the exception of stepped payments) are subject to a €4.50/£4 handling charge.

# Am I eligible for financial assistance?

The student grant is the main source of financial help available in the **Republic of Ireland** for students in full-time Post Leaving Certificate courses (PLCs) and full-time higher education undergraduate courses. For eligible students, the grant is there to help with the various costs of participating in further or higher education. Students on part-time courses, access or foundation courses (in higher education institutions) and short courses are not eligible to apply for a student grant. If you think you are eligible for the student grant, you should apply for it as soon as possible (online application for 2012-13 is now open). Full details on the Student Grant scheme (2012), including associated legislation, are available on www.grantsonline.ie. The closing date is the 31st August 2012.

ROI students who are unemployed or in receipt of social welfare can also apply for various schemes which let you return to study and keep your benefits. These include the Back To Education Allowance (BTEA) and the Vocational Training Opportunities Scheme (VTOS). There is also the option to study the qualification through FÁS in one of our approved FÁS centres around the country.


Students in **Northern Ireland** can access information on www.studentfinanceni.co.uk which will outline your various funding options. Please note that our QCF approval as a Level 5 Diploma means the qualification is now classified as a Higher Education course. As such, if you are studying part-time, you will be able to apply for a grant towards your fees and course costs from your local Student Finance NI office. There is a broad range of grants, loans and government sponsored schemes available so NI students are best advised to research those which best suit their individual circumstances.

# Can my employer assist financially?

Yes, many of our students are already in the workplace and a large number receive financial support from their employers to sit our exams. Indeed, in the current business environment, more employers are now encouraging employees to obtain a professional qualification and are making it a focal point in the appraisal process as they recognise the need to have a skilled accounting workforce. Many employers will offer help to pay for tuition and professional fees and also allow staff time off to study and take exams.

# What is KnowledgePoint?

KnowledgePoint is the new blended learning programme dedicated and tailored to Accounting Technicians Ireland students which offers supplementary learning supports in key course areas.

#### A more flexible way to learn

KnowledgePoint is a vital learning aid for exam preparation, supplementing your existing college lectures and providing an excellent way to learn and revise course material. You will be able to study and revise in your own time, at your own pace, and in whatever location is most convenient. And what's even better, you will be able to review the content as many times as you like in the run up to your exams.

All KnowledgePoint online tutorials and workshops are priced with students' budgets in mind and are accessible instantly throughout the academic year, by simply accessing the student portal TouchPoint from home, work, college, library or even when you're on holidays. KnowledgePoint brings together the best of both face-to-face and online learning.

#### **Online Tutorials**

There are 24 First Year and 24 Second Year online tutorials available covering a variety of topics. These range from 20 minutes to 1 hour. Viewing an online tutorial is virtually the same as being in the room with the lecturer. Keeping pace is easy because the video, audio and slides are all synchronised in real-time as the lecturer speaks. In addition to this you can download high quality lecture notes that help you learn in your own time, at your own pace.

#### Workshops

Workshops provide tuition by subject experts using practical examples and hands on learning activities. These interactive sessions are focused on helping you to achieve exam success.

They are half-day classroom-based sessions, designed to give you an in-depth understanding of key aspects of the course. You have the option to attend the face-to-face classroom session or view the recorded version from the comfort of your home. If you attend the workshop you will also be given the recorded version so that you can replay it at home anytime you want.

There are two Workshops for each subject in First and Second Year, each of which concentrates on different areas of the syllabus. The topics have been carefully selected to focus on core areas and sections of the course that have proven difficult for students in past exams.

# What is required for my work experience?

In addition to passing our exams, students must also have two years relevant work experience to complete the qualification.

The reason for the work experience is that students also need "on-the-job" skills to be effective as a qualified Accounting Technician and be able to apply practical experience to the theory they have learned in the classroom. This in turn provides potential employers with independent reassurance that you are the right person for the job.

Work experience requirements are based on two years full-time employment (or the equivalent part-time) and can be gained at any time. If you have relevant work experience from a previous job, then you can count that towards your two years. Accounting Technicians Ireland will also recognise any relevant experience obtained while you are studying or after you have completed your exams.

All of your experience has to signed off by a mentor who can verify that you have achieved all of the associated learning outcomes. To begin achieving your work experience, you will need to:

- find a workplace mentor (this can be your line manager, employer or a qualified accountant)
- gain two years experience in an accounting or finance-related role(s)
- record your progress using the Record of Work Experience form and have this verified by your mentor
- submit your Record of Work Experience to Accounting Technicians Ireland. (Please note that students must have successfully completed all their exams before they can submit this form).

# What areas should I be gaining experience in?

Accounting Technicians Ireland has a flexible approach in reviewing the precise experience that students need to gain, given the wide variety of Accounting Technician roles. Students have a choice of completing 13 different work based assessments but only need to achieve nine of these assessments. They cover areas like:

- Accounting systems management (e.g.TAS/Sage)
- Budgeting
- Cash management
- Computer systems
- Costing
- Credit control
- Management accounting
- Payroll administration
- Preparation of accounts
- Purchases accounting
- Quality control
- Sales accounting
- Stock control
- Tax returns

Your mentor will be able to help you plan your work experience effectively, and Accounting Technicians Ireland will be able to assist with any queries you may have.



# How do I get Work Experience?

If you are not already working, work experience can be gained in any number of ways. For example through placements, part-time jobs, voluntary work, internships, or job shadowing. These allow you to gain experience and skills in a particular field or industry with a view to working in that industry in the long term.

Make sure you cast a wide net when searching for work as you will need to follow a similar process as that of finding any other job; e.g. job boards, local companies, recruitment agencies, careers services, networking and exhibitions. Here is some advice on where to start in your job search.

- Make use of all your contacts. Speak to friends, family, colleagues, class mates and let them know you are looking for some accounts related work.
- If you know someone who runs their own business, volunteer to help them with their accounts.
- Ask your current employer about working in the accounts department (perhaps one afternoon per week). If your organisation has an external accountant then ask them about possible work placements.
- Use social networking sites such as Facebook or Linkedin to increase your profile.
- Attend industry events and sign up for any accountancy newsletters seeking out any opportunities that may arise.
- Use all relevant media sources newspapers, industry publications, recruitment websites, professional bodies, education providers, company websites.





# How do I complete the qualification?

Once students have passed the exams and obtained their two years relevant work experience, they will have completed the Diploma for Accounting Technicians qualification.

In order to complete the qualification, you must submit your Record of Work Experience which has been verified by your mentor, along with an assessment fee of  $\leq 175/\pm 150$ .

In tandem, you may also become a Full member of the professional body Accounting Technicians Ireland, which enables you to use the professional designation MIATI after your name.
